On or about February 6, 2009 through February 6, 2009, in the above named judicial district, the crime of **FORGERY, in violation of PENAL CODE SECTION 470(d)**, a felony, was committed by Eric Lamonte Smith, who did, with the intent to defraud, falsely make, alter, forge and counterfeit, utter, publish, pass and attempt to offer to pass, as true and genuine, **GRANT DEED DOC. # 2009-0052850**, knowing the same to be false, altered, forged and counterfeited.

COUNT 10

On or about February 6, 2009 through February 6, 2009, in the above named judicial district, the crime of **PROCURING AND OFFERING FALSE OR FORGED INSTRUMENT, in violation of PENAL CODE SECTION 115(a)**, a felony, was committed by Eric Lamonte Smith, who did unlawfully and knowingly procure and offer a false and forged instrument, **GRANT DEED DOC # 2009-00052850**, to be filed, registered, and recorded in a public office within this state, which instrument, if genuine, might be filed, registered, and recorded under a law of this state or the United States.

On or about November 21, 2008 through November 21, 2008, in the above named judicial district, the crime of **FORGERY, in violation of PENAL CODE SECTION 470(d)**, a felony, was committed by Eric Lamonte Smith, who did, with the intent to defraud, falsely make, alter, forge and counterfeit, utter, publish, pass and attempt to offer to pass, as true and genuine, **GRANT DEED DOC. # 2008-0524562**, knowing the same to be false, altered, forged and counterfeited.

COUNT 12

On or about November 21, 2008 through November 21, 2008, in the above named judicial district, the crime of **PROCURING AND OFFERING FALSE OR FORGED INSTRUMENT, in violation of PENAL CODE SECTION 115(a)**, a felony, was committed by Eric Lamonte Smith, who did unlawfully and knowingly procure and offer a false and forged instrument, **GRANT DEED DOC. # 2008-0524562**, to be filed, registered, and recorded in a public office within this state, which instrument, if genuine, might be filed, registered, and recorded under a law of this state or the United States.

COUNT 13

On or about September 1, 2008 through September 1, 2008, in the above named judicial district, the crime of **GRAND THEFT OF PERSONAL PROPERTY, in violation of PENAL CODE SECTION 487(a)**, a felony, was committed by Eric Lamonte Smith, who did unlawfully take money and personal property of a value exceeding Nine Hundred Fifty Dollars (\$950), to wit RENT PROCEEDS IN EXCESS OF \$10,000 the property of Herbert Hennes .
